Since the inception of the program, the grant has evolved to promote capital investment and expansion of occupied commercial, industrial, and office buildings as a means of aiding the retention and expansion of existing businesses. The Grant is administered by the GLCEDC and funded by a grant from the Livingston County Board or by funds from the GLCEDC treasury.
