



Recent Accomplishments

Since 2015, the GLCEDC and its partners have worked with over 30 companies and five area school districts resulting in: over 3,500 jobs created and/or retained; enhanced approximately 3M square feet of manufacturing and retail space; spurred nearly \$100M in capital investment; and impacted the education of nearly 4,000 Livingston County students through our Science, Technology, Engineering, and Math (S.T.E.M.) programming initiatives.

ECONOMIC INCETIVES GRANT

The GLCEDC disbursed Employment Incentive Grants leading to the creation and retention of approximately 2,000 jobs and totaling over \$3.8M to: Alloy Specialties, Blackstone; Anthony Liftgates, Pontiac; Advanced Technology Recycling, Pontiac; Caterpillar, Pontiac; Lifetime Auto, Dwight; Slagel Meats, Forrest; Technical Metals, Fairbury; Vactor, Streator; and Wally's, Pontiac.



PROPERTY TAX ABATEMENT

Anthony Liftgates, Pontiac; BMCH Properties, Fairbury; Caterpillar, Pontiac; Sealtite, Fairbury; Selig Group, Forrest; and Technical Metals, Fairbury; and Zimmerman Feed Solutions, Chatsworth received property tax abatements resulting in the creation and retention of over 350 jobs, and improvement of over 900,000 square feet.



BUILDING IMPROVEMENT GRANT

The GLCEDC impacted the education nearly 4,000 students with over \$241,000 in Education Enhancement Stimulus Grants for S.T.E.M. (Science, Technology, Engineering, and Math) to: The Livingston Area Career Center (LACC), Pontiac; District #429, Pontiac; Prairie Central CUSD #8, Fairbury; Woodland CUSD #5, Streator, and Flanagan – Cornell #74, Flanagan.
